## **MICHIGAN SCANNER LAW...**

Michigan Section Manager Dale Williams, WA8EFK, reports more news on the progress towards an update of Michigan's Scanner Law. Dale testified before the Michigan Senate Judiciary Committee on February 7th in support of the revised version containing the Amateur Radio Exemption. It was passed by the Judiciary Committee unanimously and then passed by the full Senate 37 to 0 on February 14th. You may view this legislation at:

This legislation will replace the existing MCL 750.508 and continues to exempt ham operators from any restrictions on carrying a receiver capable of monitoring Public Safety frequencies. The Governor was expected to sign the bill around the end of February.

## **COMMERCIAL RADIO TESTING...**

George, W8FWG announces the formation of the "Upper Peninsula Radio Examiners (UPRE). Commercial (not "ham") exams are given according to this schedule: The second Saturday of each quarter: March 11, June 10, Sept 9 and Dec. 9, 2006. The exams are held in Calumet at the clubhouse of the Copper Country Radio Amateur Association, Inc. Pre-Registration is necessary. We work under the direction of the National Radio Examiners of Dallas, Texas (NRE). We are the only Commercial Testing group in the U.P. of Michigan. Four other teams are available, but are all in the LP of Michigan. We also will give exams "on demand".....if a candidate is willing to travel to Calumet for the exam. The test fee of \$35 covers team expense plus expenses of the NRE, and is non-refundable. If you, or someone in your area would like to take a Commercial Test let me know. The following licenses are issued for a 5-year term: Marine Radio Operator, GMDSS Radio Operator' s License, GMDSS Radio Maintainer' s License, Third Class Radiotelegraph Operator' s Certificate, Second Class Radiotelegraph Operator' s Certificate, First Class Radiotelegraph Operator' s License. The following licenses are issued for the holder' s lifetime. Restricted Radiotelephone Operator Permit and General Radiotelephone Operator Permit (GROL).....this last one replaced the old First Class Radiotelephone License. ## **FCC MUM ON MORSE...**

**From the ARRL Letter**

Just when the FCC will act on the "Morse code" proceeding, WT Docket 05-235, remains hazy. The Commission released a Notice of Proposed Rule Making and Order (NPRM&O) last July proposing to eliminate the Element 1 (5 WPM) Morse code requirement for all license classes. The Amateur Radio community has filed more than 3800 comments on the proceeding, and additional comments continue to show up, even though the formal comment deadline was last October 31 (with reply comments by November 14). The next—and most-anticipated--step for the Commission is to formally adopt any revisions to its rules and conclude the proceeding with a Report and Order (R&O) that spells out the changes and specifies their effective date.

"There really is no news," an FCC Wireless Telecommunications Bureau staffer told ARRL this week on background. "We certainly hope to release WT Docket 05-235 sometime this year, but we' re not making any predictions at this time. We certainly are not saving up any big announcements for Dayton Hamvention."

The proceeding began with 18 petitions for rule making--many just calling for the elimination of the Morse requirement but some asking for more far-reaching changes in the Amateur Service rules. The various petitions attracted a total of some 6200 comments. The FCC subsequently consolidated the petitions--including one from the ARRL asking the FCC to establish a new entry-level license class and to retain the

Morse requirement only for Amateur Extra class applicants--into a single proceeding designated WT 05-235.

The FCC has not proposed extending HF privileges to current Technician licensees who have not passed a Morse code examination. In its NPRM&O the FCC suggested that in a no-Morse-requirement regime, "codeless Techs" could gain HF access by taking the Element 3 General class written examination.

Any FCC decision to eliminate the 5 WPM Morse code requirement for HF access would have \*no\* impact on either the current HF CW-only subbands or on the CW privileges of Amateur Radio licensees.

Before it releases an R&O on the Morse code proceeding, however, the WTB wants to wrap up action in another Amateur Radio-related docket--the "Phone Band Expansion" (or "Omnibus") NPRM in WT Docket 04-140, released April 15, 2004.

In that NPRM, the Commission proposed to go along with the ARRL' s Novice refarming plan aimed at reallocating the current Novice/Tech Plus subbands and expanding portions of the 80, 40 and 15 meter phone bands. The FCC also agreed with an ARRL proposal to extend privileges in the current General CW-only HF subbands to present Novice and Tech Plus licensees (or Technicians with Element 1 credit). WT 04-140 further proposed to essentially do away with FCC rules prohibiting the manufacture and marketing to Amateur Radio operators of amplifiers capable of operation on 12 and 10 meters.
