THE FCC RETIRES CORES...

Thanks to Ed, KG8CX, for coming across this issue.

The FCC recently announced they are retiring their legacy CORES (Commission Registration System) on July 15th. What does this mean for you? It depends. If you are a licensed Amateur, you used the CORES system to obtain that FRN you need to file applications in the Amateur Radio Service. The FRN is the way the FCC finds your profile information, like name and address. Now comes the tricky part, the FCC started with what we will refer to as the legacy CORES system, but in 2016, moved on to what is referred to as CORES2. They did not automatically transfer the information from the old system to the new system. And now that the legacy CORES is going away, if your FRN was created in that system, before 2016, you'll want to register it in the CORES2 system, because if you don't you'll lose the ability to manage your FRN, including changing the password connected to it.

If you obtained your FRN in 2016 and beyond, you're already in the CORES2 system, and do not need to do anything.

For us oldtimers (I got my FRN in 2000), there is action that needs to be taken by July 15th. It's not very difficult, and it took me about 10 minutes.

You need to go to the CORES2 site at

https://apps.fcc.gov/cores/userLogin.do

and set up an account. (The Website just says CORES, there is no reference to CORES2). Your email will be your user name, and you'll need to create a password for the account. Once the account is created, and you've verified your email, you can associate your user name to your FRN. Your FRN is on your license, or you can use the search function on the CORES page. Once you have your FRN associated with your user name account, you are able to fully manage the data associated with the FRN, including the password.
